CSEA E-BOARD ELECTIONS: We will be accepting nominations for E-Board officers at the October and November Chapter meetings. EMS Classification Study: We are in the middle of the EMS Classification Study. The focus groups have met and EMS is working to get the data reviewed and working on job descriptions. Going to School? CSEA can help!

Member Career Grant applications are due October 31st

\$1,000 CSEA Member Career Grants—Member Career Grants are awarded to CSEA Members each year who are in school on a part or full time basis. Applications are due October 31, 2016.

Up to \$250 CSEA Member Reimbursement Subsidy Grants—Subsidy grants are awarded to members who are pursuing an opportunity that connects them to the union, the community, and/or students. Applications are accepted year round.

\$500 CSEA Member Student Loan Reducer Grants—Grants to help members reduce their student loan debt. Applications are due February 1, 2017.

\$500-\$4,000 Union Plus Scholarship—Because CSEA is affiliated with the AFL-CIO, CSEA members and their dependents, including spouses, are eligible to apply for Union Plus scholarships. Go online to apply today at www.unionplus.or/scholarships. Applications are due January 31, 2017.

A Message From the President

<u>For information</u>: Last year, a task force developed a Tobacco Policy for Merced College, which was then tabled due to a similar policy on the Governor's desk. This policy is expected to be signed by the Governor very soon. The Tobacco Policy the Merced College task force developed was then placed back on the September Board of Trustees agenda and discussed. This is due to the grant MC received in order to assist with signage, cessation methods, education, etc. This policy is to make MC completely smoke- and tobacco-free (same as the bill on the Governor's desk). The Board will vote on this at the October meeting, whether or not the Governor signs the bill. If approved, the move to become a smoke- and tobacco-free campus will begin in January.

<u>Hiring Committees / Pool</u>: I am in the process of collecting names of people willing to be placed in a pool to be called upon for hiring committees. As you may know, Equal Employment Opportunity (EEO) states that we MUST have a diverse pool of committee members for EVERY hiring committee. This is the LAW. 


Welcome New Classified Employees

Negotiations Updates:

Hello,

The district and the CSEA Negotiating Committee met on Sept. 14 and continued negotiations for Article 33: Pay and Allowances under our 2015-16 contract. At this point, discussions and gathering data continue.

We voted some changes to the job classification for the Instructional Support Technician II CDC position on Friday, Sept. 23, but it did not pass. We are also working on a new job classification in ITS and we expect to bring this one to the chapter for ratification soon.

The EMS benchmarking study is in full swing. The focus groups have met with EMS and discussed their job classifications and duties. The next step will be for EMS to send the gathered data and information to supervisors for their input, some additional editing may then be made, and then the info will be sent back to the classified professionals for further review.
